

## OFFICIAL CONTEST RULES

### 1. CONTEST PERIOD

The contest « Win a trip to Venice Italy on AIR FRANCE » is organized by Lyon à la Carte and our partners AIRFRANCE

The contest starts: 5 February 2010 and ends 14 February 2010 at 23 h 59.

### 2. ADMISSIBILITY

2.1 This contest is open to all registered visitors and volunteers of the 2009 expat expo and those who register for the Lyon à la Carte newsletter and website. The participant must be over the age of 18 years and offer proof of their identity; birth date and the winning ticket. (ID must be verified by a government issued photo nationality/identity card and/or passport. You must be a citizen or legal alien living in the Grand Lyon France).

2.2 You are not eligible if you are associated with Lyon à la Carte, are an advertising and/or promotional firm involved with this contest, a firm supplying material for this contest or of the prize supplier, a member of the immediate family (mother, father, brother, sisters, daughters sons and spouses) or living with the above mentioned persons.

2.3 For the purpose of the present rules the participant is the person registered by full name on the entry form and online database via our website [www.lyonalacarte.com](http://www.lyonalacarte.com).

2.4 You can only register time to win the two tickets. If you register more than once the other claim tickets will be voided and only the first registration ticket will be accepted as the legal ticket for the contest drawing on Tuesday, 16 February 2010.

### 3. PARTICIPATION

### 4. PRIZE

One (1) trip for two or two (2) round-trip tickets to Venice Italy valued at 500€

The trip includes:

Round-trip airfare for 2 adults via our partner AIR FRANCE – Lyon France Saint Exupéry Airport (LYS) to Venice Italy Marco Polo Airport (VCE).

The trip does not include: Transfers between the airport and the hotel

The prize has no cash value and cannot be transferred, exchanged, refunded or auctioned online.

### 5. DRAW

5.1 A random draw will be held February 16th, 2010 at 2 PM at Starbucks Bellecour 85 rue de la République, 69002 Lyon. All eligible entries received at/ or prior to the closing time and date of the contest will be eligible for the draw. You do not have to be present to win.

5.2 Five names will be drawn but there will be only ONE winner. The winner will be announced on our Website at [www.lyonalacarte.com](http://www.lyonalacarte.com), by phone and email. If the winner does not claim or respond to the notification by telephone and/or email, the other names drawn on 16 February will be used to award the AIRFRANCE round-trip ticket for two adults.

5.3 To be declared a winner, the person whose entry form was drawn must be declared eligible as stipulated in article 2 of the present rules.

5.4 The Organizer will advise the winner by telephone and/or by email. All incomplete or invalid entry forms will be rejected. The Organizer will take all necessary steps to contact the winner. Should the winner not be reached within two (2) business days following the draw, the prize will be deemed lost and the next names in order of the draw will be declared the winner and or until a winner is found from those registered.

5.5 Chances of winning depend on the total number of eligible entries received.
